##I COULD RUN DOWN A LIST OF NATIONAL AMBITIOUS ACTIONS TAKEN BY THE GOVERNMENT OF SEYCHELLES, WHICH SOME, ARE HAVING A SIGNIFICANT REVENUE VALUE LOSSES IMPACT TO OUR PEOPLE. THE GLOBAL CONCERN IS NOT ABOUT WHAT LITTLE POLLUTION MY COUNTRY IS MAKING. IN CONTRAST TO THE EMISSIONS BEYOND OUR SHORES. LISTENING TO WHAT IS BEING DONE GLOBALLY, IN THE MINDS OF SIDS, WE ALWAYS WONDER WHETHER IT IS ENOUGH. WE WANT TO CONVEY TO YOU ALL, TO UNDERSTAND AND ACCEPT OUR VULNERABILITY NATURE AS SMALL ISLANDS AND TO THAT OF LDCS AMONGST OTHERS, IN WHATEVER DECISION TAKINGS YOU MAKE, NOT TO FORGET US, NOT TO VOLONTARILY AND UNCONSCIOUSLY MARGINALIZE US IN YOUR DEVELOPMENT AGENDA, BUT TO ALWAYS UPHOLD THE UN VALUES AND PRINCIPLES OF LIVING NO COUNTRY BEHIND.

AS SIDS WE THANK OUR BILATERAL AND MULTILATERAL PARTNERS FOR THE VARIOUS SUPPORT TOWARDS OUR NATIONAL MITIGATION AND ADAPTATION EFFORTS. THANK YOU FOR EVERYTHING.

LET US BE MORE ACCOUNTABLE AND RETHINK OUR ACTIONS, WICH IS A CRIME TO HUMANITY LONGTERM AND PROGRESSIVELY.

##IT IS TIME NOW FOR CONCRETE POLITICAL COMMITMENTS OF ENGAGEMENTS FOR REDRESS.

IT IS TIME FOR MODEL LAW FRAMEWORK TO RESPOND TO THE MODERN DISASTERS AND RISKS.

LET US QUESTION THE MULTILATERAL GOVERNANCE SET UP, TO PUSH FOR A MUCH FAIRER, INCLUSIVE AND DEMOCRATIC PROCESSES TO INFLUENCE THE MUCH NEEDED CHANGES . LET US RECONCILE OURSELVES WITH OUR CREATOR FOR DIVINE GUIDANCE, GRACE AND FAVOUR TO BE BRAVE AND BOLD AND TO HAVE WISDOM AND TO EXERCISE PRUDENCE FOR PRECISION IN OUR COLLECTIVE RESPONSES.

LET US GET MESSY BY COLLECTIVELY PUTTING OUR HANDS INTO THE DOE TO ENGINEER AND CRAFT OUR FUTURE AND TO ENSURE NATIONAL, REGIONAL AND GLOBAL SECURITY AND HOPE.
