(b) Working Group on Transparency, Accountability and Openness

The Governing Council will be invited to endorse the Code of Conduct for IPU Governance Officials and the Terms of Reference of the IPU Oversight and Ethics Committee.

The Governing Council will be called upon to approve the list of future inter-parliamentary meetings, as recommended by the Executive Committee.

16. Election of the President of the Inter-Parliamentary Union

The Governing Council will elect a new President to replace Mr. Duarte Pacheco (Portugal), whose term of office expires at the 212th session.

17. Elections to the Executive Committee

(cf. Article 21(k) of the Statutes and Rules 37, 38 and 39 of the Governing Council)

The Governing Council will elect 10 members of the Executive Committee to replace: Ms. P. Krairiksh (Thailand), Mr. A. Saidov (Uzbekistan), Mr. I. Flores Garcia (Chile), Mr. R. Rabbani (Pakistan), Ms. E. Anyakun (Uganda), Mr. J.F.N. Mudenda (Zimbabwe) and Ms. J. Alm Ericson (Sweden), whose terms end at the 212th session of the Governing Council, Ms. O. Kefalogianni (Greece), who has been appointed minister; and Mr. J.I. Echániz (Spain) and Mr. F. Marchand (France), who are no longer members of parliament.
