Dear Sir,

In October 2023, at the 147th Assembly to be held in Luanda, Angola, the Inter-Parliamentary Union will be expected to elect a new President for the IPU for the next three years.

I wish to advise and give notice to your office of my intention to contest for the position of President of the Inter-Parliamentary Union during the 147th IPU Assembly.

I am currently serving as the Speaker of Parliament of Malawi up to 2025/26, when Malawi will hold parliamentary elections. I have over 15 years of experience working in the political scene since 2009 when I was first elected as a Member of Parliament for my Constituency.

In 2019, I was elected as the first ever female Speaker of the Parliament of Malawi. One of my milestones during my tenure of office as a Speaker, was when I successfully led the House through one of the most politically challenging times of our country in 2019/2020.

I am committed, Sir, once elected to the position, to serve the citizens represented in all the countries at the IPU and contribute to the growth of the Organization and prosperity and peaceful coexistence among the countries of all Member Parliaments.

Right Honourable Catherine Gotani Hara, MP was elected as the first female Speaker of the Malawi National Assembly in 2019.

An accomplished, inspirational and fearless politician, she has been on the leading edge of Malawian politics, taking bold stands at various critical periods in the nation's political history and successfully leading one of the most historical and challenging parliaments in democratic history.

In her three-years in office, she guided the House implementing politically difficult court judgements that nullified the 2020 presidential elections, and successful legislation of the associated enabling laws.

Working in one of the most dynamic and vibrant democracies on the African continent, she is making progress on the IPU's mission through

empowering the Parliament of Malawi by championing and securing more autonomy from the Executive through an Act.

She established the budget office to strengthen Parliament's oversight role, overseeing the setup of e-Parliament, progressing the digital Parliament agenda and making notable strides towards citizen engagement through diversification of parliamentary communication including the setting up of the ParliamentaryTV.

Prior to this, Right Honorable Hara held key cabinet portfolios in Health, Environment, Gender, and Community Development, and Transport and Public Works.

Previously, she worked for the then Department of International Development (DFID) where she was responsible for DFID vulnerability programmes in Malawi and Mozambique.

She is also an innovative astute entrepreneur who over the years has established successful enterprises in agri-businesses, energy, retail, confectionary and transport. Through these initiatives, she has created over 200 jobs for some of the most vulnerable Malawians.

The variety of her experience is a testament to both the depth and breadth of her experience that goes way beyond her professional area of expertise, equipping her with critical insight into key global issues like climate change, Health, rural livelihoods, and infrastructure delivery.

She is well-respected for her leadership as evidenced by local and international awards, the range of international organizations that work with her in championing various initiatives and the doubling of development partners' direct financial support to the National Assembly.



MY VISION

I would like to inspire the rebranding of the IPU as a powerful global organisation which will be perceived as both locally relevant, and capable of solving global challenges. Therefore, globalising and localising the IPU's identity will require a strong result-oriented internal culture, plus the creation of a powerful external narrative about its work and achievements.

Working hand in hand with the Secretariat, I will:

- Use my regional leadership skills to map new ways of inter-parliamentary work that can facilitate dialogue that is locally effective, responsive, and inclusive, while firmly responding to global challenges;
- Review the ways in which global parliaments can be supported

further to accelerate the pace of achievement of IPU strategic goals and mission;

- Redefine and strongly communicate the IPU's role in supporting the development of solutions to existing and new threats around; geo-politics, global security, the environment, inequality and social-economics;
- Identify ways of increasing the IPU's regional visibility and people's sense of the IPU's presence;
- Make the IPU an exemplar of institutional global inclusivity, through continued advocacy on youth and women empowerment, and in particular new ways of supporting parliaments with increasing representation of disabled people;
- Advance the IPU's global influence through strengthening existing partnerships, creating diplomatic channels and developing new knowledge exchange mechanisms with other global and geopolitical and regional entities and
- Identify impactful models of communication that can relay the IPU's mission and relevance to both local and global spaces.



An active promoter of inclusivity, gender equality and youth empowerment

I am an active promoter of gender equality and youth empowerment starting with leading a vibrant women's and youth parliamentary caucus which delivers high profile parliamentary campaigns for the girl child and the youth, to taking up ambassador and champion roles for various initiatives by influential global organisations e.g.

- Plan International Ambassador for promoting Girls education
- Supported United Nations in Malawi spotlight initiative - gender related laws
- Champion for Association of Women in media – Speaking out against sexual violence
- Champion for Oxfam/Concern Worldwide/Action Aid – 16 Days of activism against gender-based violence
- An Ambassador for World Vision International – Campaign to end child marriages
- An Ambassador World Vision International – Child participation forum (youth parliament).

Some strides are being made on representation for young people though more needs to be done. However, I am aware that other marginalised groups such as the disabled, are almost systematically excluded from getting as far as the IPU because of in-country barriers to their participation and my vision is to make bigger strides in supporting countries take initiatives that remove those barriers.

I also plan to also review how the IPU can better support in-country initiatives to not only increase the election of women and young people, but to sustain them through achieving their re-election while finding new ways of stimulating changes that may support more people with disabilities.



CLIMATE ACTION AND SUSTAINABLE DEVELOPMENT

As an ex-Cabinet Minister of Environment and Natural Resources I am well versed in the global challenge that is climate change. Many of the initiatives across the world are just not going far enough to mitigate the effects.

The recent Cyclone Freddy in Malawi and Mozambique strengthens my resolve to make a difference on this agenda.

I support the IPU's recent ***parliaments for the planet initiative*** and I plan to champion its wider take up and implementation across the IPU membership.
