Vacancies to be filled during the 147th Assembly

All candidatures need to be accompanied by a signed covering letter and a brief curriculum vitae (one page maximum) specifying Committee membership in parliament and familiarity with the issues covered by the IPU body for which a seat is being sought, as well as a photo and completed contact information form (see <u>Annex</u>).

In keeping with the provisions of the IPU Statutes and Rules, candidates should have experience and expertise, as far as possible, in the relevant areas of work, and they should be supported by their respective Parliament in carrying out their functions as IPU office holders (including in terms of being included on the national delegation to IPU Assemblies and other relevant events). Every effort should also be made to include young MPs and encourage candidatures from new Members of the IPU as well as from parliaments that do not hold other offices in the IPU.

President of the Inter-Parliamentary Union

On 27 October 2023, the Governing Council will elect a new President to replace Mr. D. Pacheco (Portugal), whose term of office expires at the end of the 212th session of the Governing Council (cf. * In accordance with Article 25.6 of the IPU Statutes, if a member of the Executive Committee ceases to be a parliamentarian, the IPU Member concerned shall appoint a substitute to serve until the next session of the Governing Council, when an election shall be held. If the newly elected member is from a different parliament to the outgoing member, s/he will serve a full term. Otherwise, the new member shall complete the term of office of his/her predecessor.

* * * * * *

In accordance with the Rules of the Standing Committees:

- Members of the Bureau shall be elected for a term of two years and may be re-elected for a further period of two years.
- When a member of the Bureau has served for four consecutive years, two years must elapse before that person may again be elected to the same Bureau.
- Representatives of a Member shall not simultaneously hold more than one post as President or Vice-President of a Standing Committee, or hold a post in the same body for more than four consecutive years.
- Members of a Bureau who are absent for two consecutive sessions, without a valid reason, may lose their seat on the Bureau by a decision of the corresponding Committee. In such cases, a new election will be held at the next session of the Standing Committee to fill the respective vacancy.

Committee on the Human Rights of Parliamentarians

On 27 October 2023, the Governing Council will elect **one member** to replace Ms. A. Gerkens (Netherlands), who is no longer a member of parliament.

Please note that although the composition of this Committee should reflect an equitable geopolitical distribution of seats, members of the Committee are elected in their individual capacity on the basis of their competence, commitment to human rights and availability, and not as representatives of their parliament or geopolitical group.

In light of the Committee's current composition and its rule on the promotion of gender equality, interested female parliamentarians from the Arab, Asia-Pacific and Eurasia geopolitical groups are strongly encouraged to submit their candidatures.

Parliamentarians wishing to become members of this Committee are required to meet a set of distinct criteria. Candidates are therefore requested to complete the form available on the IPU website: www.ipu.org/file/17310/download. Candidatures may be submitted up to 09:00 on Thursday, 26 October 2023.

Bureau of Women Parliamentarians

On 23 October 2023, the Forum of Women Parliamentarians will elect members to fill the following vacancies in the Bureau of Women Parliamentarians:

- One regional representative for the **Arab Group** (end of term: March 2025), to replace Ms. H. Ramzy Fayez (Bahrain), who became an ex-officio member of the Bureau after presiding over the 35th session of the Forum of Women Parliamentarians in March 2023;
- Two regional representatives for the **Eurasia Group** (end of term: March 2027) to replace Ms. Z. Greceanîi (Republic of Moldova) and Ms. E. Vtorygina (Russian Federation), who concluded their term in March 2023 and were not replaced at the previous Assembly;
