For all vacancies, candidatures should be accompanied by a signed cover letter and a brief (one-page maximum) curriculum vitae, as well as a completed contact information form (see www.ipu.org/download/5971). In addition, candidatures for the Standing Committee Bureaux should include a written commitment from the candidate's parliament, and candidates for the Committee on the Human Rights of Parliamentarians are required to complete the vacancies form available at https://www.ipu.org/sites/default/files/documents/form_vacancies_chrp_april_2019-e.pdf.

Candidatures from the geopolitical groups concerned, and, where applicable, from candidates, may be submitted to the Submission and Control of Documents Service (Dukhan Hall), up to 12 noon today, Saturday, 6 April 2019 for the Bureau of Women Parliamentarians; up to 6 p.m. today for the Forum of Young Parliamentarians of the IPU; and up to 9.30 a.m. on Tuesday, 9 April 2019 for the Committees and other bodies. For the Standing Committee Bureaux, candidatures may be submitted up to the time of the elections.

BUREAU OF WOMEN PARLIAMENTARIANS

At its meeting today, Saturday, 6 April 2019, the Forum of Women Parliamentarians will hold elections to fill the following **two vacancies** in its Bureau (end of terms: March 2020): one regional representative for the African Group; and one regional representative for the Eurasia Group. The Forum of Women Parliamentarians will also be called upon to approve the nomination of Ms. A. Al-Basti (United Arab Emirates) to fill the position of First Vice-President of the Bureau of Women Parliamentarians and Ms. A. Tolley (New Zealand) to fill the position of Second Vice-President of the Bureau of Women Parliamentarians. These nominations were decided by the Bureau of Women Parliamentarians at its 42nd session held on 18 October 2018.

FORUM OF YOUNG PARLIAMENTARIANS OF THE IPU

At its meeting on 7 April 2019, the Forum will elect its Board. All Geopolitical Groups are invited to submit two candidatures (one woman and one man). Please see the Forum's revised agenda for details regarding the election of the next President.

On 10 April 2019, the Governing Council will hold elections as outlined below.

EXECUTIVE COMMITTEE

The Governing Council will be required to elect one member (female) for the African Group.

COMMITTEES AND OTHER BODIES

Committee on the Human Rights of Parliamentarians

The Governing Council will be required to elect **one member** (to serve in an individual capacity), preferably from the Asia-Pacific Group.

Committee on Middle East Questions

The Governing Council will be required to elect one member (female).

Group of Facilitators for Cyprus

The Governing Council will be required to elect **one facilitator**.

To date, the following candidature has been received:

- Ms. L. Quartapelle (Italy).

Committee to Promote Respect for International Humanitarian Law

The Governing Council will be required to elect **two members**: one member (female) for the Asia-Pacific Group; and one member (male) for the Eurasia Group.

High-level Advisory Group on Countering Terrorism and Violent Extremism

The Governing Council will be required to elect **21 members**: five members (at least two female and two male) for the African Group; two members (one female and one male) for the Arab Group; four members (two female and two male) for the Asia-Pacific Group; two members (one female and one male) for the Eurasia Group; three members (at least one female and one male) for the Group of Latin America and the Caribbean (GRULAC); and five members (at least two female and two male) for the Twelve Plus Group.

STANDING COMMITTEE BUREAUX

The following elections to the Bureaux will be held.

Standing Committee on Peace and International Security

Five members: One member (female) for the African Group; two members (at least one female) for the Asia-Pacific Group; and two members (at least one female) for the Eurasia Group.

Standing Committee on Sustainable Development, Finance and Trade

Two members: One member (female) for the Asia-Pacific Group; and one member (female or male) for the Eurasia Group. In addition, the Bureau members from Jordan and Romania are completing their first two-year term and are eligible for reelection for a second term.

Standing Committee on Democracy and Human Rights

Three members: one member (female) for the Arab Group; one member (female or male) for GRULAC; and one member (female or male) for the Twelve Plus Group. In addition, the Bureau members from Burundi and Canada are completing their first two-year term and are eligible for re-election for a second term.

Standing Committee on United Nations Affairs

Two members: One member (female or male) for the African Group; and one member (female or male) for the Asia-Pacific Group. In addition, the Bureau members from Argentina and the Russian Federation are completing their first two-year term and are eligible for re-election for a second term.
