- Mr. K. Kosachev (Russian Federation) one vacancy to be filled by either a man or a woman from the Eurasia Group;
- Mr. A. Lins (Brazil) one vacancy to be filled by a man from the Group of Latin America and the Caribbean (GRULAC);
- Ms. H. Haukeland Liadal (Norway) one vacancy to be filled by a woman from the Twelve Plus Group.
