On the outset of the spread of Coronavirus (COVID-19) pandemic, Heads of states and leaders of the world came out and spoke to their people about what happened and will happen in light of the pandemic outbreak and its health, economic and social implication.


In this context, H. H. the Emir of the State of Kuwait, Sheikh Sabah Al-Ahmed Al-Jaber Al-Sabah, addressed to his people at the beginning of the spread of the epidemic and I will focus on the most important sentence that H.H. said and stressed on which is, (the world after the Coronavirus, will not be the same again.)

From this sentence, I will start my speech.

What we thought was important but can be postponed, in now urgent and cannot be postponed. The futile disputes and senseless conflicts should be critically examined.







Issues that we thought to be an intellectual and cultural luxury like climate change, the environment, food and water reserves, and global coordination, cooperation and interdependence in the field of health have become urgent, necessary and existential files.

The pandemic took the world by surprise. It showed that international agendas were lost, and that global priorities were in chaos. It revealed that no country or people could live on an isolated island under the pretext of cultural privacy, state sovereignty or phobia of the other persons, especially if this person is different, religiously, ethnically and culturally.

After COVID-19

The terms, such as international cooperation, sustainable development and protecting earth from pollution etc., which we may have been broad and general slogans, will become terms with a very urgent and necessary practical significance.

Our first responsibility as parliamentarians under these circumstances is to create a real global human solidarity aimed at promoting all the protection measures for humans, especially for the most vulnerable such as the elderly, children, people with special needs, victims of wars and refugees, and those under the poverty line.

Our responsibility as parliamentarians around the world is to strive to create a human culture that focuses on the common human goals and on those issues that impose themselves on our societies in one way or another.

No country is immune from economic recession No country is safe from the unemployment

No country is content with its health system or its durability and readiness to deal with any epidemics such as COVID-19.
